MINUTES OF THE MEETING OF THE MEMBERS OF GOVERNORS ISLAND CORPORATION d/b/a THE TRUST FOR GOVERNORS ISLAND

November 20, 2025

The meeting of the Members of Governors Island Corporation d/b/a The Trust for Governors Island (the "Trust") was held on Monday, November 20, 2025 in the Governor's Room at City Hall, New York, New York 10007.

Members of the Trust were present as follows:

Madeline Labadie, delegate for the Mayor of the City of New York (the "City"); and Sarah Mallory, delegate for the Deputy Mayor for Housing, Economic Development and Workforce.

Clare Newman, the Trust's President and CEO, acted as the Chairperson.

Also present were Trust staff.

Ms. Newman started the meeting at approximately 4:05pm. Daniel Hantman, the Trust's General Counsel and Secretary, confirmed that a quorum was present.

1. Approval of the Minutes of the Members' Meeting on December 16, 2024.

Upon motion duly made and seconded, the minutes of the Members' Meeting held on December 16, 2024 were unanimously approved.

2. Appointment of Alicia Glen as Chairperson of the Board of Directors of the Trust.

Ms. Newman presented the item, which proposed Alicia Glen for re-appointment as Chairperson of the Trust's Board of Directors.

Upon motion duly made and seconded, the resolution attached hereto as <u>Schedule 1</u> was unanimously adopted.

3. Appointment of Directors to the Board of Directors of the Trust.

Ms. Newman presented the item, which proposed Carl Weisbrod, Wendy Brawer, Susan Mercandetti, Gaurav Kapadia, Tim Cawley, Marc Norman, and Carolee Fink for re-appointment to the Trust's Board of Directors.

Upon motion duly made and seconded, the resolution attached hereto as <u>Schedule 2</u> was unanimously adopted.

4. <u>Amendment to Certificate of Incorporation</u>

Mr. Hantman presented the item, which sought authorization to amend the Trust's Certificate of Incorporation to update the addresses on file with the New York Secretary of State for purposes of service of process.

Upon motion duly made and seconded, the resolution attached hereto as <u>Schedule 3</u> was unanimously adopted.

5. <u>Presentation of the Fiscal Year 2025 Audited Financial Statements, Certification of Audited Financial Statements, and Investment Report (Non-Voting Item).</u>

Ms. Newman and Willa Padgett, the Trust's Chief Financial Officer, presented the item. The Trust's Finance Department prepared the Trust's Fiscal Year 2025 Financial Statements, which were audited by CBIZ CPAs P.C. ("CBIZ"). The Trust's Audit Committee met on September 25, 2025, where CBIZ presented a report on the audit materials. CBIZ found that the Fiscal Year 2025 Financial Statements presented fairly, in all material respects, the Trust's financial position. Additionally, CBIZ did not identify any deficiencies in internal controls considered to be material weaknesses.

6. President's Report (Non-Voting Item).

Ms. Newman provided the Members a 2025 year-end report about the Trust and the Island, including information on Island events and public programming, arts and culture, climate-focused initiatives, sustainability, Island tenants and users, and other Trust accomplishments in 2025.

7. Adjournment.

Ms. Newman asked if any of the Members had additional questions or comments. Hearing none, Ms. Newman requested a motion to adjourn the meeting. The motion was duly made, seconded, and unanimously approved, and the meeting was adjourned at approximately 4:15pm.
