TRUST FOR GOVERNORS ISLAND ANNOUNCES NEXT STEPS IN PLANS TO ESTABLISH CENTER FOR CLIMATE SOLUTIONS

Four university-led teams move to next phase of competition to anchor new center dedicated to positioning New York City as a global leader in the development of equitable climate solutions

Key Initiative as Part of Mayor Eric Adams' Economic Recovery Blueprint will Create 7,000 Permanent Jobs and \$1B in Fiscal Impact for New York City

New Climate Advisory Committee Announced

NEW YORK (April 21, 2022)— The Trust for Governors Island (the Trust) today announced the next steps in the competition to establish a global Center for Climate Solutions on Governors Island. As the final phase of a global competition, four teams led by top universities will respond to a targeted Request for Proposals (RFP) released today. Announced as part of Mayor Eric Adams' "Rebuild, Renew, Reinvent: A Blueprint for NYC's Economic Recovery," the RFP will select an anchor academic and research partner to build a new state of the art institution dedicated to researching and demonstrating urban climate solutions, and advancing education and training opportunities for New Yorkers in climate and environmental fields.

"The Center for Climate Solutions on Governors Island will position New York City as the worldwide leader in developing solutions to the crisis of our time while creating thousands of new jobs to fuel our city's post-COVID recovery," said **Deputy Mayor for Economic and Workforce Development Maria Torres-Springer.** "The newly created Climate Center Advisory Committee is made up of experts in their field that are committed to the long-term health of our city and our planet, and we look forward to their guidance as we enter the next phase of this process."

"Today's announcement represents a crucial step in establishing New York City as a global leader in the development of equitable climate solutions," **said Clare Newman, President and CEO of the Trust for Governors Island.** "Governors Island's singular environment, growing community of tenants and partners, and climate-resilient landscapes make it an unparalleled place to develop, showcase, and scale new ideas. We look forward to working with the finalist teams, as well as the newly formed Climate Advisory Committee, on the next phase of this project."

"The Center for Climate Solutions will bring together actionable science, community-based partnerships, and innovative and equitable solutions to communities on the frontline of the climate crisis. The Center for Climate Solutions is a groundbreaking initiative designed to further New York City as a global leader in efforts to respond to the climate crisis. On Governors Island, the project will support the research, development, and demonstration of equitable climate solutions for New York City that can be scaled and applied globally. Through interdisciplinary education, training, and broad public engagement opportunities, the Center will support the growth of green and climate-related jobs driving New York City's recovery from the COVID-19 pandemic and will serve as a national model for growing green- and blue-tech sectors. At full build, the Center for Climate Solutions will create 7,000 permanent jobs on Governors Island alone, and nearly \$1B in fiscal impact for the city of New York.

The four teams invited to move to the next stage in the competition by responding to the RFP were selected as finalists to anchor the Center based on visions put forth in response to a competitive Request for Expressions of Interest released in June, 2021 and are led by the following institutions:

The City University of New York (CUNY) and The New School Massachusetts Institute of Technology (MIT) Northeastern University Stony Brook University

As part of the RFP released today, selected finalist teams will have the opportunity to further refine their proposed curriculum and research program, design of facilities, phasing, and team members and structure. Pre-qualified respondents will be required to further articulate their vision for how their project will advance climate-related fields and further the City's goals, including connecting New Yorkers with educational and workforce training opportunities, showcasing innovative approaches to sustainable and resilient design, and enhancing Governors Island's unique physical setting, and creating broader opportunities for New Yorkers. Mayor Eric Adams and the Trust also announced today the formation of an Advisory Committee to support the selection of an anchor academic and research institution for the Center for Climate Solutions. This group of experts from climate science, policy, environmental justice, philanthropy, and business will advise on the city's efforts to create a Center for Climate Solutions on Governors Island throughout the RFP process and will provide input on prospective academic and research partners' proposals to a selection committee made up of City and Trust officials.

Following the response deadline, the City and the Trust will launch a process in Fall 2022 where information on received proposals will be shared with the public for input to inform the selection of an academic and research partner.
